A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PUNTA GORDA, FLORIDA, APPROVING THE INTERLOCAL AGREEMENT WITH CHARLOTTE COUNTY FOR THE ALLIGATOR CREEK WATERWAY UNIT; AUTHORIZING THE MAYOR TO EXECUTE THE INTERLOCAL AGREEMENT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Punta Gorda and Charlotte County are authorized to enter into Interlocal Agreements, pursuant to Chapter 163, Florida Statutes; and

WHEREAS, Charlotte County established the Alligator Creek Waterway Unit to provide for the dredging, maintenance, clearing, marking for navigational purposes, and provision of safety devices in Alligator Creek, so as to provide residents and marine interests within the unit a means of use and enjoyment of the waterways in the unit and to Charlotte Harbor; and

WHEREAS, the Alligator Creek Waterway Unit is funded by the imposition of special assessments against specially benefitted properties; and

WHEREAS, the City of Punta Gorda has approved an additional navigational access channel connecting the Punta Gorda Isles canal system to Charlotte Harbor via Alligator Creek; and

WHEREAS, certain parcels located within the City of Punta Gorda as well as unincorporated Charlotte County will receive a special benefit from the maintenance of Alligator Creek; and

WHEREAS, the Interlocal Agreement is intended to set forth the County's intent to impose non ad valorem assessments against the benefitted properties located in both unincorporated Charlotte County and City of Punta Gorda and set forth the City's commitment to complete construction of the additional navigational access channel project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PUNTA GORDA, FLORIDA, THAT:

1. The Interlocal Agreement between the City of Punta Gorda and Charlotte County for the Alligator Creek Waterway Unit, a copy of which is attached hereto and made a part hereof, is hereby approved.
2. The Mayor is hereby authorized to execute the agreement on behalf of the City.

3. This Resolution shall become effective immediately upon adoption.
